DEPARTMENT AND HEART OF ILLINOIS FAIR GENERAL RULES

- This event is **ONLY** open to contestants with vehicles registered in the following Illinois counties—**Peoria, Stark, Marshall, Putnam, Woodford, Tazewell, Fulton, Knox, Bureau and McLean**. This event is open to Illinois Registered Vehicles & Illinois licensed drivers only in the counties listed above. . You will be required to show proof of Illinois registration and Illinois driver's license. The vehicle registration must match the vehicle serial number.
- ALL MONIES FOR FEES MUST BE MADE AT TIME OF ENTRY.
- All contestants who enter tractor pulling classes do so at their own risk. The superintendents of the Heart of Illinois Fair assume no responsibility for any injuries to contestants.
- Scale on grounds.
- Patriot Motorsports sled will be used for Trucks.
- LEGALITY OF ENTRY** All entries must be street stock Semi Trucks. Truck must have affixed a current license plate of the state of registration and the owner must furnish the current registration card and insurance card for the vehicle & CDL.
- SAFETY CONSIDERATIONS** No riders are permitted in truck during pull attempt. Driver may not leave the driver's seat while vehicle is on the pulling track. No pit crew members, family members, helpers, assistants or the like may enter the pulling track area at any time. Driver will take all directions from the flagman on the track. Consumption of alcoholic beverages by the drivers is prohibited.
- HITCHES** The hitching device will be provided by the promoter of the event. This hitch will work from the fifth wheel only. Hitches will be placed in position and checked by officials just prior to the truck entering the track to pull. **It shall be the owner/driver's responsibility to lock the fifth wheel hitch in place.**
- WEIGHT OF TRUCK** 19,000 LBS.
- SPECIAL RULES**
 - One (1) driver per truck
 - Drivers not attending the drivers meeting will not be permitted to pull.
 - Changing or blocking of drive axles is **NOT** permitted with the exception of air ride suspensions which MUST be chained.
 - A single turbo-charger is the maximum permitted.
 - NO ether, alcohol, water, nitrous or other liquid or combustible material** may be **injected** into the turbo-charger or any part of the air intake system.
 - Only the fuel that was originally intended for that motor may be used while pulling.
 - NO ITPA OR NTPA TRUCKS.**
- OPERATION OF CONTEST**
 - Puller must register, pay all prevailing hook fees and attend the driver's meeting prior to hooking to the weight transfer machine.
 - Contest to be operated in same fashion as the other pulling classes in that session. Director of competition shall have final decision making power in any and all disputes.
 - Each puller may use the 75' mark on first attempt. Failure to reach that point shall entitle the puller to an immediate re-hook.
 - Pull-Offs may be scheduled at some time later in the program, if necessary.
